

OPINION

Framework for the assessment of third country prospectuses under Article 20 of the Prospectus Directive

Legal basis

1. Article 20 of the Prospectus Directive (2003/71/EC)¹ (“PD”) provides that the competent authority of the home Member State of issuers having their registered office in a third country may approve a prospectus for an offer to the public or for admission to trading on a regulated market, drawn up in accordance with the legislation of a third country.
2. This opinion explains a framework for third country share prospectuses under Article 20 and sets out the role of the EU Member States’ competent authorities in scrutinising prospectuses under these arrangements.
3. ESMA’s competence to deliver an opinion is based on Article 29(1)(a) of Regulation (EU) No 1095/2010² (“ESMA Regulation”). In accordance with Article 44(1) of the ESMA Regulation, the Board of Supervisors has adopted this opinion.

Background

4. Following requests from market participants and the European Commission, CESR decided to work on a common assessment of prospectus standards of certain third countries vis-à-vis EU standards. On 1 July 2012 the amended Prospectus Directive³ and Commission Delegated Regulation No 486/2012⁴ entered into force. Following the entry into force of this legislation and the entry into force of Commission Delegated Regulation (EU) No 862/2012⁵ on 22 September 2012, ESMA conducted a review of the framework for third country prospectuses and has updated and revised it accordingly. The framework adopted by ESMA is designed to ensure a uniform application of the PD. The framework sets out ESMA’s view on how a third country issuer that has drawn up a prospectus in accordance with a third country’s legislation can meet the requirements of the PD. This arrangement is not a comment on third country prospectus regimes but recognition of the potential for differences between those regimes and the PD. Where the PD requires

additional information, the framework identifies the information that can be added to the third country prospectus as an equivalence ‘wrap’ so that the resulting document meets the requirements of the PD.

5. The annex to this opinion sets out a categorisation of disclosure requirements under the PD, which will be used by ESMA to assess what disclosure will need to be included in the wraps for prospectuses from specific third countries. ESMA’s presumption is that all items should be addressed based on a literal interpretation of the words used therein. However, in forming a view on what should be included in a wrap, ESMA recognises that there are alternative ways in which disclosure can be made and that this can be compatible with the requirements under the PD. This might, for example, be in a descriptive way instead of in a numeric manner, and vice versa. Where a third country prospectus regime meets the PD requirement on this basis, ESMA considers that additional disclosure will not be needed in the wrap. However, ESMA recognises that this approach will not be possible for all items and has therefore categorised such items as Category A.
6. On application from a third country competent authority, or on its own initiative, ESMA will publish an additional opinion on the application of this framework to identify the specific information that will be required in a wrap to prospectuses from a particular third country where ESMA considers it will be useful to do so. ESMA reserves the right to decline applications for an examination of a third country’s prospectus regime under the framework.

The framework:

1. Based on an examination of the third country prospectus regime, ESMA will decide what additional information will need to be included in a wrap to the third country prospectus to make it equivalent with the requirements under the PD.
2. In order to make the framework for this assessment clear to third country issuers, ESMA has categorised the items that appear in Annexes I, II, III, XXII, XXIII, XXIV, XXV & XXX to Commission Regulation 809/2004 (“Prospectus Regulation”) in the Annex to this Opinion in the following way:
 - a. Where the third country prospectus regime does not require a prospectus to include information relating to a Category A item in the form set out in the Prospectus Regulation, ESMA considers this information will have to be provided in the wrap in the same form specified under the PD.
 - b. Where the third country prospectus regime does not require a prospectus to include information relating to a Category B item in the form set out in the Prospectus Regulation, ESMA considers the information will have to be provided in the wrap unless the third country is able to demonstrate to ESMA that its prospectus disclosure requirements meet the Category B requirement for that item (i.e. that the substantive disclosure appears in a different form from that set out in the Prospectus Regulation but investors would nevertheless be able to make the same informed assessment that they would make if the disclosure appeared in the form set out in the Prospectus Regulation).
 - c. Where ESMA is of the view that only part of an item is met under a third country prospectus regime it will include the other parts of the item in the list of material to be in the wrap.

- d. The summary of the prospectus must be in the form set out in Annex XXII (Category A), including the mandatory order of information within the summary. Where the third country regime does not require a prospectus to include a summary in the form set out in Annex XXII, the summary will have to be provided in the wrap.
3. Based on this methodology, ESMA will publish an additional opinion which will contain a list of the items which will need to be included in a wrap to a prospectus from a specific third country.
4. Where ESMA has published such an opinion, third country issuers can request the competent authority in the home Member State to make use of the arrangement.
5. Issuers seeking to make use of this arrangement should make their application to the competent authority in the home Member State. The application should be accompanied by written confirmation from the issuer that its third country prospectus has been drawn up in accordance with the legislation of the third country.
6. Where an item is required to be disclosed in a wrap the third country issuer must make the disclosure in the form set out in the Prospectus Regulation.
7. This arrangement does not remove any of the requirements under the PD. For example, it does not affect the PD provisions relating to the omission of information.
8. The competent authority in the home Member State will scrutinise the third country prospectus and the wrap. The competent authority can, if satisfied that the requirements are met, approve the third country prospectus and the wrap together as a prospectus under the PD. However, nothing in this framework prevents a competent authority from requiring an issuer to include additional or modified disclosure relating to the information in the wrap and the third country prospectus on a case by case basis in accordance with the EU prospectus regime.
7. Where a third country prospectus and a wrap have been approved as a prospectus under the PD, the PD approved prospectus may be passported into other Member States. The third country prospectus on its own would not be capable of being passported.
8. ESMA will periodically review any opinions that it issues concerning the contents of wraps for third country prospectuses under this framework. Please be advised however that if changes have been made to the prospectus regime in the EU after the adoption of this opinion, or additional opinions in relation to particular third countries, those changes can affect the material on which the opinion is based. Accordingly, no reliance should be placed on such opinions or the framework pending an update of such by ESMA. Similarly, ESMA will reconsider any such opinions in the light of significant changes in the prospectus regime of the third country. Competent authorities of third countries that have made a successful application for an arrangement under this framework should notify ESMA of any significant changes in their prospectus regime which might affect the assessments made hereunder.
9. Where a prospectus is required under the PD but not under the third country's requirements an EU prospectus will be required.
10. In addition, the third country competent authority should normally in the first instance provide ESMA with an assessment of its prospectus regime against the requirements in:

Article 20.1(a) PD; and



Article 20.1(b) PD,

as this body is in the best position to make this comparison.

ANNEX

The items in Annexes I, II, III, XXII, XXIII, XXIV, XXV & XXX of the Prospectus Regulation have been categorised as either A or B:

- Category A** Items where equivalence under Article 20.1(b) of the Prospectus Directive requires that the substantive disclosure must appear in the form set out in the Prospectus Regulation's annexes.
- Category B** Items where equivalence under Article 20.1(b) of the Prospectus Directive is provided by substantive disclosure which may appear in a different form from that set out in the Prospectus Regulation's annexes because it is reasonable to think that investors would nevertheless be able to make the informed assessment they would make if the disclosure appeared in the form set out in the Prospectus Regulation's annexes.

Such financial information must be prepared according to Regulation (EC) No 1606/2002, or if not applicable to a Member State national accounting standards for issuers from the Community. For third country issuers, such financial information must be prepared according to the international accounting standards adopted pursuant to the procedure of Article 3 of Regulation (EC) No 1606/2002 or to a third country's national accounting standards equivalent to these standards. If such financial information is not equivalent to these standards, it must be presented in the form of restated financial statements.	✓
